From Georgeann:

This hearing is the first meeting of creditors, only. The U.S. Trustee will be in attendance, the representative from SSH, perhaps a representative from the Office of the United States Trustee (OUST), perhaps the Trustee's attorney, Gail Higgins and Georgeann Nicol will be in attendance. They will be there to discuss the filing of the case, regarding the assets and the liabilities. It will probably be continued for a "2004 Exam", which is a more in depth examination regarding the assets, liabilities, transfers, relationship between companies (SSH, AES, ORIX), etc. It will be a limited exam by the Trustee. It might last five minutes, it could go on for an hour.

Gail & Georgeann will also be available for Q&A and an analysis of the hearing, right after the hearing, at the courthouse.

I, Tony Vaca, webmaster for the Student Support website (yeah, I know that is way formal), am a registered and certified travel agent (CST #1008730-40). I have just received a fantastic Group Rate at the Stratosphere Hotel on the north end of the Strip. This is one mile south of the Courthouse. Rates are: \$39 for Sunday night, \$109 for Saturday night and \$144 for Monday night. You can have any combination of the above, however, there are limited Saturday night rooms. If you email me, I need to know: days you want booked, one bed or two, smoking or non, credit card #, exp. date, phone # and billing address. They will be charging for the first night. I will only use your cards on your own room, if the rate hasn't changed. I can also book airline tickets from around the U.S. For SoCal travelers, it is cheaper to book out of Long Beach to Las Vegas on JetBlue (\$89 out on Sunday, \$69 back on Monday) on Jetblue.com. For others, I can sometimes save you money. Also, I can do car rentals. Yes, I know, blatant plug for business, but we all have to scrape up money. And a travel agent will often get you better rates than you can get yourself and the service provider pays the commission, not the traveler.

I have been asked about carpools from Southern California, Sacramento, Los Banos, Oakland, and yes, even Portland. Anyone interested, I have created a carpool log on the website. I won't be organizing the carpools, but will monitor the log for content.
